Dear Valued Customers,

Advanced Sterilization Products (ASP) recently was notified that a limited quantity of expired units and beyond shippable date units of CIDEX® Activated Glutaraldehyde Solution product, product code SCX145, lot 020315018, were shipped to customers in Singapore.

CIDEX® Activated Glutaraldehyde Solution is a liquid chemical sterilant and a high level disinfectant for reprocessing heat sensitive medical/dental devices such as endoscopes, respiratory therapy equipment and ultrasonic transducers. CIDEX® Solution is intended for use in manual systems as well as in automated endoscope re-processors.

Sterilant:

CIDEX Solution is a sterilant when used or reused, according to the Directions for Use, at or above its Minimum Effective concentration (MEC) as determined by the CIDEX® Solution Test Strip, at 25°C (77°) with an immersion time of at least 10 hours with a reuse period not to exceed 14 days.

High Level Disinfectant:

CIDEX Solution is a high level disinfectant when used or reused, according to the Directions for Use, at or above its Minimum Effective Concentration (MEC) as determined by the CIDEX® Solution Test Strip, at 25°C (77°) with an immersion time of at least 45 minutes with a reuse period not to exceed 14 days.

Description of the Issue

ASP has concluded that the issue is bounded to nine (9) bottles (4 expired and 5 beyond shippable life) of CIDEX® Activated Glutaraldehyde, lot 020315018, shipped to three (3) customers in Singapore. This issue is limited to this specific lot and customers only.

Please note that a field notification letter was attached to each of the bottles with the instructions to subtract 12 months from the product expiration date.

What Actions Are Recommended?

- Ensure anyone in your facility impacted by this notification reads this letter. In the event expired product was used, ASP recommends that healthcare facilities follow their risk management procedures as it relates to this notification.
- ASP advises the customer to check your current inventory of CIDEX® Activated Glutaraldehyde Solution, product code SCX145. If you have inventory of lot 020315018, DO NOT USE the product and immediately return the affected products by following the instructions in the section below for product return and replacement.
