

# Urgent Medical Device Field Correction - Immediate Action Required Sony LMD-1951MD Monitor used with SpyGlass

Dear Materials Manager / Field Action Contact:

Boston Scientific, on behalf of Sony Electronics Inc., is implementing this Medical Device Field Correction for specific Sony LMD-1951MD Monitors used with SpyGlass. In some situations, the Sony Monitor may either not turn on, or may lose image during use. The issue is the result of a potential disconnection of the internal power supply caused by a failure of a power board integrated circuit. The failure mode does not occur when an AC adapter is used with the monitor. See Background Information (page 5) for Sony risk assessment of this issue.

#### Immediate Action to be taken by customer

- 1) If you possess an AC adapter for your affected monitors, only use the AC adapter when the monitors are in use.
- 2) If you do not possess an AC adapter for each of the affected monitors, stop using the monitor and take the monitor out of service.
- 3) For each of the affected monitors follow the Sony correction instructions document enclosed with this letter (*AC Adapter Setting Procedure and Completion Report*). Per the instructions (1) affix the warning sticker (warning that the AC inlet should not be used) to the rear of the monitor; and (2) place the adhesive seal over the AC inlet.

#### Permanent corrective action to be taken by Sony Electronics, Inc.

Sony Electronics Inc. will send a representative to your facility to replace the power board of any affected units with a redesigned power board that does not exhibit this failure mode. The new power boards will be installed during future field service visits beginning in approximately February 2015. You will be contacted beginning in February 2015 with respect to scheduling the replacement of the power board. Until the unit(s)' power board has been replaced, continue to follow the Immediate Action above.

This issue only affects Spy Glass Video Monitors (SONY LMD-1951MD) in the table below. Affected products can be identified by confirming the serial numbers on the product label affixed at the rear of the monitor.
