## Dear Hospital Administrator:

Boston Scientific is retrieving certain lots of 9Fr ACUITY Pro Coronary Sinus Outer Guide Catheters due to potential for separation of the proximal handle from the shaft.

## Background

The ACUITY Pro 9Fr Outer Guide Catheter is designed to provide a pathway into the coronary venous system for implantation of a left ventricular pacing lead. The Catheter has a proximal handle with an integrated hemostasis valve and a shaft with a flexible distal segment. Once the left ventricular lead is placed, the handle and distal segment are cut and removed.

Boston Scientific has received reports of handle separations during the cut and removal process; there have been no reported patient harms. After full investigation, Boston Scientific concludes that if the hub and shaft are aligned off-center in the bonding equipment during manufacturing, the result may be a reduced bond, which may separate during cutting. The affected product listed below was manufactured during the time period when the equipment was likely to be misaligned.
