Dear ladies and gentlemen,

You are using the medical device SeQuent Please 2.0 x 20 mm with the article number REF 5022220 LOT 16E02809 in your interventional cardiology.

Verification of the batch history record of a complained product revealed that one product of the referenced batch contains a different SeQuent Please catheter than mentioned in the outer product label. The primary packaging inside the cardboard box may be labelled as and contains a SeQuent Please 2.5 x 15 mm REF 5022206. Labelling information in primary packaging may not comply to the information given in the secondary packaging labelling.

Vascular Systems has not received information regarding patient injury in conjunction with this product non-compliance.

After careful failure cause analysis Vascular Systems came to the conclusion that both products had been mixed within two good orders on August 17, 2016. The applied process has been adapted meanwhile to make sure that this product failure can be avoided in the future.

We hereby ask you not to use the referenced articles. Furthermore we would like to ask you to review your stock for the affected products and to prepare products for handover to our sales representative. 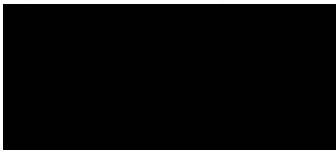

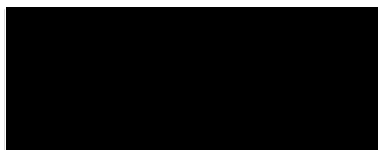
