Re: MODULARIS Variostar with display freeze on MODULARIS hand control

Dear customer,

This letter is to inform you of a potential malfunction and hence hazard to patients:
Display freeze of MODULARIS hand control results in information not being updated on the display.
Current treatment data are not shown to the user.

When does this malfunction occur and what are the potential risks?

On rare occasions the display of the MODULARIS hand control freezes and the information on the display is not updated. Neither the number of applied shock waves nor other parameters which have been changed by the user on the hand control will be displayed. This might result in insufficient information for the treatment.

What steps can the user take to avoid the potential risk of this issue?

- Whenever parameter changes are performed on the MODULARIS hand control, please ensure that the display is showing the new updated values.
- If the display of the MODULARIS hand control freezes, interrupt the treatment immediately.
- Disconnect the MODULARIS hand control from the basic unit MODULARIS Variostar and reconnect it. The hand control will initialize automatically and will show the correct values. Then the treatment can be continued.

Currently the potential malfunction of incorrect treatment data display can only be mitigated by the user checking that the hand control's display is showing the new updated values after parameters have been changed.

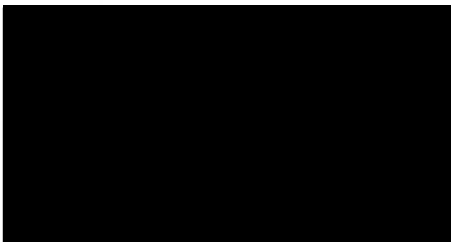
How will the issue finally be resolved?

We are working intensely to provide a solution which permanently resolves the potential malfunction. As soon as this solution is available, all affected systems will be updated.

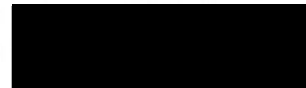
