Re: SOMATOM Definition AS manufactured from May 2008 until December 2013 and SOMATOM Definition Flash manufactured from September 2009 until July 2012

Dear customer,

We would like to inform you about a hardware issue of your SOMATOM CT and the related corrective action.

When does this malfunction occur and what are the potential risks?




Fig. 1a: SOMATOM Definition Flash

We became aware, that in rare cases the small light marker window (see Fig. 1a and 1b) used for the positioning laser and integrated in the front cover of your CT could loosen and potentially drop out. In this case there is a risk that a person touches rotating or electrical parts of the gantry when reaching through the window opening. There is a risk for serious injury e.g. by electrical shock or physical harm to fingers.




Fig. 1b: SOMATOM Definition AS

How can the operator help to avoid the potential risk of this issue?

Dear Customer,

We would like to inform you about a hardware issue of your SOMATOM CT and the related corrective action.

When does this malfunction occur and what are the potential risks?




Fig. 1a: SOMATOM Definition Flash

We have been informed that the small light marker window (see Fig. 1a and 1b) used for the positioning laser and integrated in the front cover of your CT had loosened in the past. The problem has subsequently been fixed by your local service specialist. We now became aware that the repaired light marker window could loosen again and potentially drop out. In this case there is a risk that a person touches rotating or electrical parts of the gantry when reaching through the window opening. There is a risk for serious injury e.g. by electrical shock or physical harm to fingers.




Fig. 1b: SOMATOM Definition AS
