A problem has been detected in the Philips BrightView family of gamma cameras (BrightView, BrightView X, and BrightView XCT), that, if it were to re-occur, could pose a risk for patients or users. This Field Safety Notice is intended to inform you about:

- what the problem is and under what circumstances it can occur
- the actions that should be taken by the customer / user in order to prevent risks for patients or users
- the actions planned by Philips to correct the problem.

AFFECTED PRODUCTS	BrightView SPECT BrightView X and BrightView XCT
PROBLEM DESCRIPTION	An issue has been found with the handcontroller for the BrightView Family of cameras that results in either spontaneous uncommanded (not initiated by the operator) motions or continued motion after the buttons were released. Philips continues to investigate the issue.
HAZARD INVOLVED	The detector(s) may unexpectedly move until and collide with the patient, operator, or equipment, such as a patient bed. It is possible for a portion of the detector that is not equipped with collision detection to come into contact with any of the above mentioned objects, potentially resulting in entrapment and/or serious injury.
HOW TO IDENTIFY AFFECTED PRODUCTS	This issue applies to all versions of BrightView, BrightView X, and BrightView XCT. The product can be determined by selecting Help > About JETStream as shown in Figure 1.




