Please read carefully the urgent **Field Safety Notice** published by the manufacturer Trinity Biotech, regarding the products RPR 100 (code 72505) and RPR 500 (code 72506) which were distributed by Bio-Rad . Our records indicate that you have purchased the above product and we would like to share the following important information with you.

Investigations conducted by Trinity Biotech have shown that the impacted kits may fail to detect weak positive samples.

By consequence of this notification, Trinity Biotech asks users to stop using lots detailed in table 1 and to destroy them.

We remind you that these products have been replaced in our catalog by the RPR 100 (code 72515) and RPR 500 (code 72516) manufactured by Bio-Rad . These two products are not affected by this Safety Notice. Similarly the RPR cards (code 72508) are still available at Bio-Rad catalog.

Please fill and return the annex after inventory of your stocks, in order to make us able to replace the concerned products manufactured by Trinity Biotech with products manufactured by Bio-Rad.

We would like to inform you that the Authorities are aware about this notification.
