Dear Beckman Coulter Customer,

Beckman Coulter is sending you this letter relating to possible background failures for the DxH 800 and DxH 600 instruments. Please note that Red Blood Cell (RBC) and Platelet (PLT) Counts may be affected.

ISSUE	Beckman Coulter has identified an issue where the RBC aperture baths can contain residue in the sweep flow fittings. This residue may potentially create increased background failures, flagged results and vote outs for RBC and PLT parameters.
IMPACT	<ul> <li>You may experience:</li> <li>Daily Checks Background failures for RBC and/or PLT.</li> <li>Non-numeric codes for complete vote outs () or flagged partial vote outs for the RBC and/or PLT parameter results.</li> <li>No other parameters are impacted.</li> </ul>
RESOLUTION	<ul> <li>Address any Daily Checks system alarms and background failures as indicated in the Online Help or Instructions for Use (part number B26647AC and B16421AD).</li> <li>Monitor flags on patient and control results according to your laboratory protocols.</li> <li>Beckman Coulter Support will contact you to schedule a service visit for the replacement of the RBC aperture bath.</li> </ul>

Share this information with your laboratory staff and retain this notice as part of your laboratory Quality System documentation. If you have forwarded the affected product to another laboratory, please provide them with a copy of this letter.
