During internal functional testing, it was determined that product failed to meet shelf-life at the expiration date indicated on the product labels.

For the purpose of this communication, the products being recalled were manufactured, packaged, labeled, and branded by ArthroCare Corporation at the time of shipment. The manufacturer of the products being recalled is ArthroCare Corporation.

This field action has been reported to the relevant competent authorities.
