This field action has been reported to the relevant competent authorities.

Risks to Health	In the event the affected instrument is presented for use and the surgeon is unable to eject the head from the stem using the device, the surgeon would use an alternate instrument to remove the implant. The use of or exposure to the affected device presents a low risk adverse health consequences.
