Smith & Nephew, Inc. has initiated a Field Correction for currently produced SPEEDLOCK⁽⁾ Knotless Fixation Implants, Catalog # OM-7500, due to an interference fit issue between the SPEEDLOCK Implant inserter and drill guides (Catalog # OM-9715 and OM-9716). The potential interference fit of the SPEEDLOCK Inserter (OM-7500) could prevent the insertion of the SPEEDLOCK implant through the drill guides. A drill guide is used at two stages of the procedure per the SPEEDLOCK IFU P/N 62513 revision B. The drill guide is first used in the procedure to align corresponding drill to prepare the implantation site, and then used later in the procedure to guide the user in delivering the SPEEDLOCK implant to the prepared site. No interference fit occurs when the drill guide is used with the SPEEDLOCK Knotless Fixation devices.

Potential Risk with Use of the Product

Not all cases require the use of the drill guide. If the user elects to implant the SPEEDLOCK device by using the drill guide, the drill guide may interfere with the movement of the SPEEDLOCK inserter device. In the worst-case scenario, the user will notice the interference fit before the procedure is completed. The surgeon would use a new instrument or elect not to use the drill guide to complete the procedure.

Actions for Hospital Representatives

- Communicate this potential interference with operating personnel so that they can plan to use the cannula to guide and deliver the SPEEDLOCK implant to the prepared site or elect to make adjustments to their proposed surgical plan as appropriate.
