REASON FOR FIELD ACTION:

Customers are to be advised of the following:

An internal technical investigation has confirmed that the following **products and lot numbers** listed below may fail performance testing per the Instructions for Use (IFU) starting at 57 days after date of manufacture (**see list below**).

Therefore, product used within the first 56 days will perform as intended per the IFU. See list below, column "Updated Expiration Date (MMDDYYYY)".

RISK TO HEALTH:

This product is recommended for use in qualitative procedures as a general purpose medium for the cultivation of aerobes and anaerobes.

The immediate health consequence may be a delay in the recovery of anaerobic bacteria associated with an infectious process. Clinical risks are mitigated as it is typical for other culture media to be inoculated (e.g. Blood agar or anaerobic plates) for isolation of these aerobic and anaerobic species from clinical specimens in conjunction with the fluid thioglycollate medium. Furthermore, the risk is mitigated by the empiric treatment for anaerobic infections prior to bacteria isolation in patients already suspected of having an anaerobic infection. This is mainly due to the longer incubation time for anaerobes, which can be up to several days. This empiric treatment reduces the probability that patients with suspected anaerobic infections are at greater risk of impaired clinical response.

Additionally, performance failures are detectable when used as recommended per the Instructions for Use. Therefore, it is unlikely there would be immediate or long term health consequences.
