How to move the unit manually

Dear customer,

Agfa HealthCare is committed to providing you with the best possible customer care and highest quality products and services. Agfa HealthCare wishes to bring to your attention the following information.

#### Device:

This notice refers to the mobile Digital Radiography X-Ray System unit DX-D 100.

#### **Background information:**

In case motorized movement is not possible the unit needs to be moved manually. The procedure how to switch to manual movement and the tool needed is mentioned in the User Manual and also explained below.

#### **Actions**

#### • Procedure how to switch from motorized to manual movement.

"In case the unit has to be moved manually, the two clutch screws (Allen type) located on each wheel must be removed with the Allen wrench provided with the unit. This will uncouple the wheels from the motors (releasing the brakes) allowing the free motion of the unit."

#### Storage of Allen wrench



1. A box or roll of protective bags for the detector The slot can be used for storing the Allen wrench that is used to uncouple the wheels from the motors.
