




Profile of Manufacturers for Inspection Conducted in Year 2023






Therapeutic Products Manufacturers Inspected in 2023






Chinese Proprietary Medicine Manufacturers Inspected in 2023





Top 5 GMP Deficiencies for Pharmaceutical Finished Product* Full Manufacturers




Top 5 GMP Deficiencies for Pharmaceutical Finished Product* Packagers




Top 5 GMP Deficiencies for Full Manufacturers of Therapeutic Products






Top 5 GMP Deficiencies for Packagers of Therapeutic Products










